#### Important Procedure

General Cleanliness at shows - Exhibitors are reminded that it is their responsibility to pick up/ clean their dog's poo at show ground. Exhibitors caught breaking these clealiness rules will be given an automatic one show ban. All dogs owned and co-owned by them at the time of the offence, will also automatically be suspended from one show, even if they are transferred to new owners.

- 1 Illness The GSDOAM shall not be liable for any form of illness or disease that dogs may contract at show. Exhibitors are required to take every reasonable precaution to prevent the introduction of diseased or sick animals to the Show. The sale of dogs at the show venue is strictly prohibited.
- 2 Any dog entered must not have registered or recorded as having owned, by the judge within the period of six (6) months immediately preceding the show. The only exception shall be in the case where an emergency Judge is appointed to replace the advertised Judge.
- 3 Expelled or suspended members of GSDOAM/ MKA are not allowed to handle dogs in the ring. All foreign exhibitors who are showing here temporarily can do so, so long as they are registered members for their respective local Canine authorities that are recognized and have recipprocal agreements with the GSDOAM/ MKA. If Handler is not a Registered Member of GSDOAM/ MKA, they will be required to sign up as a Member of the GSDOAM on day of the show on the membership form.
