RULES ON MATING CERTIFICATE (Bitches Imported in Dam)

The MKA reserves absolute and unequivocal right not to register a litter in the following circumstances

- 1. A copy of this certificate must be submitted to the MKA, **together** with MKA FORM 3 (Transfer of Ownership of a Registered Dog) at or before time of the Registration of the Litter. This certificate will NOT be accepted if MKA Form 3 is not submitted.
- 2. In the case of dogs or bitches that are co-owned, all co-owners must sign this Mating Certificate, unless there is a letter of authorization given by the co-owners.
- 3. For Puppies Imported in Dam, the Application for Registration of Litter (MKA Form 2) must be lodged with the MKA within one (1) month from the date of birth of the Litter. This includes the 2 (two) colour photographs that the MKA requires. Please see MKA Form 2 for description of the photos required.
- 4. All puppies Imported in Dam may be subject to a Litter Inspection. An inspection fee of RM50.00 will apply and has to be paid by the applicant.
- 5. For Pedigrees for the puppies to be issued, applicants have to fulfill/submit the following:
 - a) This original mating certificate with all relevant signatures and information.
 - b) Certified True Copy/Extract of Pedigree of the Sire's pedigree issued by the Kennel Club where the sire is registered.
 - c) Ensure all requirements contained in MKA Form 2 & MKA Form 3 are satisfied.
- 6. Kindly ensure that the information given overleaf is correct, legible and complete. Incomplete, illegible or incorrect information may result in delay or refusal to register a litter of puppies by the MKA.
- 7. The information given overleaf cannot be altered once this certificate is submitted to the MKA.
- 8. MKA shall not be responsible for any loss through ordinary post. The MKA advises the use of either registered post or courier service .

The MKA reserves the absolute and unequivocal right to reject a Mating Certificate that does not comply with ALL the rules and requirements stated above.
