INSTRUCTIONS TO COMPLETE ENTRY FORM

General Notes:

- 1. This form is to used by one (1) person or partnership for MKA Members only. All handlers must be MKA members, but as an encouragement to dog sports, the Starter Class is open to Non-MKA members. However expelled and suspended members of the MKA are **NOT** allowed to enter or handle dogs in the ring.
- WEF 01/01/2021, all dogs entering any MKA trial must be microchipped and registered with the MKA or on the MKA Dog Sports Register as a dog ID will be issued to every dog to uniquely identify them and linked to their microchip numbers. All dogs entering the ring will be microchip scanned.
- 3. Dogs of any breed of either sex can enter, but must be over 6 months or older on the day of the show.
- 4. Dogs that have qualified and received the required number of certs for that class must enter the next higher class and cannot compete in the same or lower class. You also cannot enter the higher class until you have passed the lower class at MKA conducted or sanctioned DWD Trials and then become eligible to enter the higher classes
- 5. DWD requires 3 judges for each competition. Except for the head judge, those locals who are judging will also be allowed to participate in this competition when not judging in that particular class.
- 6. Teams are required to submit a thumb drive with song/music (timed & cut) on competition day to the Trial Manager. Music check will be done before start of competition. Teams will be responsible for their own thumb drive and ensure it is labelled with participant name, dog name, title of music & time and class entered. It is advisable to have duplicate thumb drive.
- 7. Entry Forms that are incomplete or those with incorrect details or without the appropriate fees will be rejected. The Exhibitor must countersign all alterations and corrections on the Entry Form.
- 8. The exhibitors Pass must be collected by the registered participant only. The Exhibitor must countersign all alterations and corrections on the Entry Form.
- 9. Only MKA member's dogs are eligible for MKA Dog Sport Award(s). Points for award(s) is only given to current (paid up) members and will not be back dated.
- 10. Owing to the special rules with regards to Covid-19 (RMCO) members agree to abide by all rules of the MKA concerning this and will be refused entry or participation for failing to observe the rules set out by the MKA.
- 11. Pls pay attention to the MKA General Show Rules Part Xi Section A (vi) with regards to use of paraphernalia.
- 12. Entry forms, together with the appropriate fees are to be submitted in person or by post to the following address on or before the closing date:

This trial will be run according to MKA DWD rules. Please check <u>www.dogsmalaysia.my</u> for the MKA DWD rules. All dogs will have to start from the Starter Class - Heelwork to Music & DWD Freestyle.

General Show rules

- 1. General Cleanliness at Shows Exhibitors are reminded that it is their responsibility to pick up/clean their dogs poo and pee at ANY show venues. Exhibitors caught breaking these cleanliness rules will be given an automatic two show ban. All dogs owned and co-owned by them at the time of the offence, will also automatically be suspended from two shows, even if they are transferred to new owners.
- 2. **Illness** The MKA shall not be liable for any form of illness or disease that dogs may contract at a show. Exhibitors are required to take every reasonable precaution to prevent the introduction of diseased or sick animals to the Show. The sale of young puppies at the show venue is strictly prohibited.
- 3. **Collecting Ring** Only handlers are allowed into the collecting ring.
- 4. **3 Calls Rule** if exhibits are not presented at the ring for judging, upon 3 calls by the steward of your exhibit number, your exhibit will be automatically scratched from further participation (even in subsequent classes) unless allowed by the judge.
- 5. **All dogs must be on a lead at all times and can only be off lead when competing in the show ring.** Exhibitors who fail to observe this rule will have their awards withdrawn and given an automatic 2 show ban for further events.
- 6. The MKA has the absolute right to refuse any entry at their sole discretion.
